

Ordinance Number: 544

An Ordinance Entitled:

Amending Ordinance Number 535 Change in Water & Sewer Tap Rates

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF BELTON, SOUTH CAROLINA.

SECTION 1. Section 12-2 of the City Code is hereby amended to reflect adjustment of the new tap rate connections as follows:

The Following will apply to all NEW INSIDE WATER SERVICE CONNECTIONS

- ¾ inch meter \$1,500.00 – tap backflow prevention device
- 1-inch meter \$2,000.00 – tap backflow prevention device
- Larger than 1 inch \$1,500.00 – plus expenses
- Companion Meter \$ 500.00 – tap backflow prevention device

The following will apply to all NEW INSIDE SEWER SERVICE CONNECTIONS

- 4 inch \$1,500.00 – tap to curb line
- 6 inch and up \$1,500.00 – plus expenses: Contractor to install

The Following will apply to all NEW OUTSIDE WATER SERVICE CONNECTIONS

- ¾ inch meter \$1,500.00 – tap backflow prevention device
- 1-inch meter \$2,000.00 – tap backflow prevention device
- Larger than 1 inch \$1,500.00 – plus expenses

The following will apply to all NEW OUTSIDE SEWER SERVICE CONNECTIONS

- 4 inch \$1,500.00 – tap to curb line
- 6 inch and up \$1,500.00 – plus expenses: Contractor to install

SECTION 2. All ordinances or parts of ordinances, in conflict herewith are, to the extent of such conflict, hereby repealed.




